MEMBER PERKS: WPCA and capital credits exceeded \$3.4 million in 2016

In keeping with our not-for-profit cooperative business principles, Tideland EMC issued credits to members and former members exceeding \$3.4 million in 2016.

Of that total, \$2.3 million was in the form of wholesale power cost adjustment (WPCA) credits that appeared on monthly power bills January through December. The average WPCA credit for the year was a -0.689¢ per kilowatt hour (kWh) but ranged from as low as -0.184¢ in July to as high

The trend of higher WPCA credits continued into 2017 with a January credit of -1.056¢ per kWh.

as -1.129¢ in November.

That equates to a \$10.56 credit per 1,000 kWh billed during the month and reduced our published winter residential rate of 10.58¢ to 9.524¢.

In addition to the WPCA credits the co-op refunded \$1.1 million in capital credits to both members and former members of the cooperative in 2016.



Rebates Extended Through Year-End

Tideland has extended its water heating and heat pump rebates through the end of year 2017. Qualifying heat pump water heaters are eligible for a \$300 rebate. Qualifying heat pumps are eligible for rebates ranging from \$75 to \$300.

While the article on the previous page celebrated the unusually high wholesale power cost adjustment (WPCA) credits issued in 2016, things may be a little less rosy in 2017.

While natural gas production remains at record highs, in 2016 the fuel had its first annual production decline since 2005. Production is expected to increase in 2017, but growing domestic consumption along with increased exports (pipeline and liquified) are expected to drive prices higher. A year ago


natural gas was priced at about \$2.39 per million Btu. By year end 2016, the cost was up to \$3.70/MMBtu.

While natural gas is expected to still outpace coal in electricity generation in 2017, forecasters predict a 2% increase in coal production in 2017 with a 3% price increase.

Fortunately, 56% of Tideland's electricity is generated by nuclear power,

which will help insulate us from fossil fuel fluctuations.


There are no indications that Tideland will have to collect more than base rates in 2017, but the trend of the last four months where we've been able to reduce charges by more than 1¢ per kilowatt hour through the WPCA is not likely to continue. The last time Tideland had to bill a WPCA in excess of base rates was December 2012.

Director nominations underway

It is once again time to nominate candidates for Tideland's annual director elections. The nominating committee will meet in Pantego on February 9, 2017, to consider candidates for districts 2, 7 and 10 currently represented by Mark Carawan, Garry Jordan and David Ipock, respectively. Interested candidates should contact a member of the nominating committee prior to the meeting. The committee's nominees will be posted at all Tideland offices on February 10, 2017.

Nominations can also be made by submitting a petition signed by 50 co-op members no later than February 27, 2017. The last day to introduce new business via petition is April 18, 2017. The annual meeting of members will be held at Beaufort County Community College on Thursday, May 18, 2017.

DIRECTOR QUALIFICATIONS

The following guidelines are excerpted from Board Policy No. 302 and Bylaw 4.02 to ensure quality representation.

Legal & Personal Requirements

- 1. A Tideland member & bonafide resident of the directorial district.
- 2. A member no less than 2 years on the date of election.
- 3. Willing to promote & protect the co-op's interests.
- 4. Able to impartially represent the entire co-op membership.

- 5. Willing to regularly attend board meetings.
- 6. May not be a close relative of an existing director or employee.
- 7. Is not employed by or financially interested in a competing enterprise.
- 8. Was not previously employed by TEMC, any other utility/energy company, or any entity which substantially rendered services to a utility/energy company.

Aspects of Service

- 1. Put forth the effort to understand the co-op and provide sound judgement to reach decisions.
- 2. Respect official decisions made by a majority of the board.
- 3. Objectively evaluate questions and problems facing TEMC.

Points to Consider

- 1. Has the member demonstrated sound business judgement?
- 2. Has the member shown a capacity for leadership & a reputation for honesty & integrity?
- 3. Has the member shown a capacity for working well with others?
- 4. What problems might hinder the nominee's success?

Wash day at the solar garden



Crews from Hannah Solar recently stopped by Tideland's Beaufort County solar garden to give the panels a routine wash. By keeping the panels clean we are able to maximize energy production. The facility is located on Hwy. 32 next to Tideland's Five Points substation. The first array became operational in December 2014 and the second was put into service 12 months later. Through September 30, 2016, the panels have generated 292 megawatt hours, which translates into 292,000 kWh. Since both arrays have been energized they have averaged 14,000 kWh per month. The average Tideland member uses 1,040 kWh per month. So our one-acre project produces enough energy to power about 13 homes a month.
