Here are 4 reasons to avoid operating your HVAC system in the ON mode:

- 1. Higher energy costs: Since the fan is always running, you're using more energy than when the fan only runs when your system is heating or cooling.
- 2. More frequent repairs: When set to ON, the fan runs more. This can increase wear and tear on your blower and lead to costly blower repairs.
- 3. Increases humidity: Your AC won't dehumidify your home as well as it should, when the fan is set to ON.
- 4. Worsens air duct leakage: Most homes leak about 10% of the supply air and 12% of the return air through their duct system. So if the fan is blowing all the time, you're always losing your conditioned air, running up your energy bills.

## They may be ugly, but... Resist the urge to transform your transformer with landscaping

Tideland crews recently had to remove three bushes, a great deal of dirt along with landscape fabric and hardscaping to access a padmount transformer during the installation of a new electric service. Crews actually had to dig down to uncover the lid bolt.

While we can appreciate the fact that padmount transformers aren't very attractive to look at, proper clearances are critical to service reliability, public safety and routine equipment inspections.

As we mentioned in last month's issue of Tideland Topics, padmount


transformers need at least 10 feet of clearance in front of the cabinet and 2 to 5 feet in all other directions.

Padmount transformers are also not appropriate canvases for individual or community art projects or the placement of decorative decals.

# Message to members A beacon for our co-op families

For years, North Carolina's electric cooperatives have proudly supported the Ronald McDonald House Charities of Eastern North Carolina (RMHC-ENC) and its mission to provide a temporary "home away from home" for families of seriously ill or injured children receiving treatment at local medical facilities.

In a recent collaborative effort, North Carolina's Electric Cooperatives, along with Edgecombe-Martin County EMC, Tri-County EMC, Jones Onslow EMC, Carteret-Craven Electric Cooperative, Tideland EMC, and Roanoke Cooperative, came together to make a generous donation of \$12,000 to the utilities fund of the RMHC-ENC. With this donation, North Carolina's Electric Cooperatives have pledged to donate an additional \$10,000 in 2024, bringing the total to \$22,000. This fund assists in covering all utility expenses for the house.

We are very appreciative to have a program and organization like the Ronald McDonald House in our community, as it impacts all of the co-ops and our members.

The House is an essential resource in eastern North Carolina, providing families with quality care and a place to rest and recharge while their children receive medical treatment. This "home away from home" can make all the difference for families during their times of need, as they are provided with basic necessities and emotional support. Since 1987, RMHC-ENC has had over 32,000 admissions to their facilities.

In 2022, RMHC-ENC provided 5,900 nights for families all over Eastern North Carolina. The charity operates two Houses in Greenville. The House on Moye



Boulevard has 25 guest bedrooms. It offers families all the comforts of home, while being in close proximity to their child in the hospital. In 2013, a second, six-bedroom Ronald McDonald House was opened inside the James and Connie Maynard Children's Hospital at ECU Health.

We are grateful to RMHC-ENC for the services and hope they provide to families in need. And proud to do our part to strengthen and continue their mission.

Students will learn how physics, global positioning, camera technologies, coding and mathematics are intertwined when utilizing drone technologies. Ten drones will be purchased to aid students in the study of precision farming and forestry services.

#### Tami Wagaman Mattamuskeet High School "Innovating Minds Through Hands On Learning"

Wagaman, one of Tideland's most successful Bright Ideas grant writers, is now teaching at Mattamuskeet High School, where she is eager to begin the process of building a lab environment for students. This grant begins to pave the way with beakers, test tubes and more.



#### Casey Schulte Northside High School "The Investigative Mind"

Speaking of Tami Wagaman, we're pleased to announce that a 2022 grant we funded during her last year at Northside High School has been adopted and expanded by teacher Casey Schulte. The 2023 Burroughs Wellcome Fund's Northeast Regional Teacher of the Year, Schulte is building out Wagaman's forensic science curriculum with the purchase of bloodstain pattern and fiber analysis kits and other items to help students hone their scientific, super sleuthing skills.



#### Susan Long Fred A. Anderson Elementary "A Book for Everyone"

An innovative arrangement at Anderson Elementary allowed Susan Long to "loop" to fifth grade with her fourth grade students. Her grant will build on last year's grant to buy

classroom sets of reading materials. Long's students were excited to learn they will now receive "Another Quest for Celeste", part two of Henry Cole's "Nest for Celeste" series which they began last year.

#### Megan Boltes S.W. Snowden Elementary "STEM and 3D Printing"

Snowden's new STEM program gets a much needed boost with the purchase of three 3D printers. Students will explore engineering, design and the manufacturing process. Using Tinkercad they will immerse themselves in the entry-level principles of constructive solid geometry to render their own printed models.







#### Karen Teklinsky Ocracoke School "Discovering How the World Around You Works"



With the purchase of reusable PocketLab sensors and probes, students in grades 6-8 will explore their natural environment by measuring altitude, motion, light, temperature, magnetic fields and more. The G-force sensor fits on a Hot Wheels track and can measure velocity, position, direction and collision. The air sensor measures CO2, particulate matter, barometric pressure and ozone.

#### Joy Powell Terra Ceia Christian School "Around the World with Art"

Art is often one of the least-funded school curriculums while having the highest need of "consumables" so students can create their own



masterpieces. This grant will provide a wide array of items from bulk construction paper to scissors and modeling clay so young learners can create.

#### Helen Lewis Bridgeton Elementary "Budding Botanists"

First graders will explore plant life cycles with classroom greenhouse kits that allow them to plant and maintain their own vegetables, flowers and herbs. A root viewer will allow students to observe the development of vegetables like carrots from seed to harvest.
